(The Organiser) and all sponsors of the ice-skating rink establishment and their subsidiaries, affiliates, partners, officers, directors, employees, agents, managers, council members and volunteers arising out of Participant's use of the ice-skating rink and all surrounding areas. Participant and/or their parent(s) or guardians hereby release and hold harmless ELH Electric Events Ltd (The Organiser) and all sponsors of the ice-skating rink establishment and their subsidiaries, affiliates, partners, officers, directors, employees, agents, managers, council members and volunteers from any and all liability for any loss, damage, or expense that the Participant or their respective heirs, assigns and legal representatives may suffer as a result of Participant's use of the ice skating rink, from any cause whatsoever, including but not limited to, active or passive negligence or breach of contract on the part of ELH Electric Events Ltd and all sponsors of the ice-skating rink establishment, in the operation, supervision, design, maintenance, or condition of the ice surface, or of the ice-skating rink and all surrounding areas.
